# **ORIGINAL** 2013 MCA BY-LAW ARTICLE 3 SECTION 2: PRESIDENT (4TH SENTENCE)

The position of President maybe held by the same person for only two (2) consecutive one (1) year terms plus a partial year prior to the two (2) one (1) year terms, if elected mid-term. After one year passes that person will be eligible to be elected President again under the terms of the position of President.

#### ORIGINAL

#### 2013 SECTION 19: SUSPENSION/REMOVAL

Any member of the Board of Governor may be suspended from the Board of Governors by the affirmative vote of the majority of the entire board or removed by members authorized to elect Board Members at any annual or <u>social</u> meeting called for that purpose; for nonfeasance, malfeasance; or misfeasance; for conduct detrimental to the interest of the Association; for lack of sympathy with it's objective; or refusal to render reasonable assistance in carrying out it's purposes. The Board Member proposed for suspension shall be entitled to at lest five (5) days notice of the meeting at which time such suspension is to be voted upon and shall be entitled to appear before, and heard at such meeting. <u>A Board Member will be automatically removed from</u> <u>the Board after missing 2 consecutive monthly meetings, that were not</u> <u>Approved by the Board of Governors.</u>

#### ORIGINAL 2013 MCA BY-LAW ARTICLE 3 SECTION 9:

#### SECOND PARAGRAPH

Regular meetings shall be scheduled for the second Saturday of every month in the Meadview Civic Association's facility. No special notice shall be required for Annual and regular meetings of the Board of Governor's.

#### PROPOSED

#### 2020 SECTION 19: SUSPENSION/REMOVAL

Any member of the Board of Governor may be suspended from the Board of Governors by the affirmative vote of the majority of the entire board or removed by members authorized to elect Board Members at any annual or **special** meeting called for that purpose; for nonfeasance, malfeasance; or misfeasance; for conduct detrimental to the interest of the Association; for lack of sympathy with it's objective; or refusal to render reasonable assistance in carrying out it's purposes. **If there are no corrections apparent in this member's action, that member shall be removed from the Board. The Board Member shall proposed for suspension must be given five (5) day notice of such meeting where the Board's reason for proposed suspension would be presented and the Board Member could present his side of the issue. Either the seated Board Members or the membership would vote on suspension.** 

<u>A Board member shall be removed from the Board after missing two</u> (2) consecutive monthly meetings that were not approved by the <u>Board of Governors.</u>

#### PROPOSED 2020 MCA BY-LAW ARTICLE 3 SECTION 9:

#### SECOND PARAGRAPH

Regular meetings shall be scheduled for the second Saturday of every **quarter for that physical year** in the Meadview Civic Association's facility. No special notice shall be required for Annual and regular meetings of the Board of Governor's.

## SPECIAL NOTICE TO ALL MCA MEMBERS LEGAL NOTICE OF ELECTION

- I. Candidate Eligibility: A slate of candidates, all of whom are members in good standing of the Meadview Civic Association, shall be selected by a nominating committee. The consent of all candidates shall be obtained before placing their names on the ballot. At the annual meeting a member present may nominate a member for the Board of Governors. No write-in candidates shall be accepted unless nominated at the annual meeting. No member nominated at the annual meeting shall be considered unless the candidate consents to serve if elected. The presiding officer shall limit nominating speeches from the to one (1) minute each.
- II. Who May Vote: Only members in good standing will be eligible to vote. To be a member in good standing that all association assessments on lots being voted, have been paid in full by **2 P.M., THE FRIDAY** PRIOR TO THE ANNUAL MEETING.
- III. Voting Eligibility: A person eligible to vote in this election must be the owner or co-owner of VIII. Installation of Officers: A. Immediately after Meadview property which is presently being assessed by the Association. One vote only may be cast for each lot so assessed. Where a lot or lots are owned by one or more persons, only one of the persons names as co-owner may vote for any one lot. Only one vote per lot is allowed. You may vote by absentee ballot if unable to attend the meeting. You must request your absentee ballot from the Secretary of the Board. Carefully follow the instructions sent with your ballot(s) and return to the Secretary. ABSENTEE BALLOTS MUST BE RECEIVED BY THE SECRETARY OF THE ASSOCIATION BY THE CLOSE OF THE LAST BUSINESS DAY PRIOR TO THE ANNUAL MEETING.
- IV. Verification of Voting Eligibility: prospective voter will be required to present proper identification prior to receiving the ballot (s) for voting. Association records will be checked to verify that such person is a member in good standing. Each prospective voter will then be given the specific number of ballots, one for each member lot, and will then cast his/her ballot(s) immediately after verification.

Voting hours shall be from the conclusion of the annual meeting to 2:00 p.m. There shall be no electioneering within one hundred (100) yards of the polling place.

- V. Ballots for Voting: Subsequent to verification of eligibility to vote, members will be given one (1) ballot for each lot for which he/she is authorized to cast a vote. Members, after verification of eligibility to vote, and receiving the ballot(s) shall proceed to vote and deposit said ballot(s) in the ballot box within ten (10) minutes. A member voting for more than ten (10) ballots shall have multiples of ten (10) minutes for each ten (10) ballots being voted.
- VI. Voting Procedures: A. In accordance with the desires of the majority of the Association members as expressed at the May 28, 1988 meeting and at the

prerogative of the present Board of Governors as authorized in Article III, Section I of the By-Laws of the Association, the number of persons to sit on the Board of Governors shall be seven (7). в. Place an "X" in the box beside the name of each all candidate you wish to vote for. On propositions, place an "X" in the appropriate box. On all proposed By-Laws changes mark an "X" in the appropriate box. C. Fold your ballot and deposit in the ballot box provided. NOTE: Voting for more candidates than seats available will invalidate the ballot.

- VII. Ballot Counting: A. After all the ballots have been cast, the Election Committee will open the ballot box and proceed to count and record the To verify votes. в. proper performance in all aspects of the election, the election will be monitored by appointed Association members.
  - the determination of names of the winning candidates, the newly elected members will assume their positions on the Board. B. In accordance with Article III of the Association By-Laws, the Board members will be elect executive officers from their owns ranks. The executive officers of the Association shall be President, Vice-President, Secretary, Assistant Secretary, Treasurer, and Assistant Treasurer.

C. This Board of Governors shall manage and control the business affairs of the Association in accordance with the terms and conditions of the Articles of Incorporation and the By-Laws of the Association.

Each IX. Voting by Absentee Ballot: Members can request an absentee ballot, one for each lot on which an assessment is paid, which will list the slate of candidate dates, Propositions, and the proposed By-Law changes. The request form for absentee ballots should be filled in and mailed to:

Upon receipt of the request form, eligibility and number of votes entitled to be cast will be determined. The ballot(s) will be mailed to the requester with a return envelope addressed to the Secretary of the Board. After indicating your choice of candidates and By-Law changes, seal the ballot(s) in the envelope addressed to the Secretary. Walk-in Absentee ballots will be accepted until, 2 P.M., THE FRIDAY PRIOR TO THE ANUUAL MEETING. Absentee Ballots received after THE FRIDAY PRIOR TO THE ANNUAL MEETING mail pick-up, will be invalid.

Upon receipt the sealed envelope with the absentee ballot showing the Bar Code of the voter shall be logged in and placed in a locked ballot box. On election Day, the Election Committee will remove the ballot from the envelope for counting purposes.



# BLAST FROM THE PAST

JULY/AUGUST 1985 Part 1

## MEADVIEW HISORY ENCAPSULATED 1960-1985

**AUGUST 1960**– Plat of first Meadview Unit (Unit 1) recorded in Mohave County.

**AUGUST 1961**– Plats of Meadview Units 2, 3, 4, 5, 6, 7 and Meadview Estates recorded in Mohave County.

**NOVEMBER 1962-** The original Meadview Marina opened on Pierce Ferry Rd to supply groceries, gasoline, etc., To visitors.

**OCTOBER 1963**– a MEETING WAS HELD IN Meadview and attended by developers Frank Glindmeier & Paul Mullane, National Park Services, & Mohave County officials to discuss development of the Upper Basin of Lake Mead. (Pierce Ferry, Sandy Point, Iceberg Canyon, Driftwood Cove, Grand Wash & God's Pocket).

**DECEMBER 1963**– First Meadview property owners card issued.

**SUMMER 1964**– Road work on Pierce Ferry Rd & Hwy 93 improves access to Meadview. All roads in Meadview Units 2,3,4,5 & Meadview Estates have been regraded, according to Meadview Development, Inc. President, Frank Glindmeier.

**FEBRUARY 1965-** Contract let for access road to South Cove & Pierce Ferry, made possible by the continuing efforts of the National Park Service, Mohave County Board of Supervisors & Rivcor. (Meadview developers)

**NOVEMBER 1966-** Meadview Terrace opens. New Meadview Marina opens featuring the snack bar. Water system is completed.

**JANUARY 1967**– Meadview Terrace officially opens. The Terrace is the first developed property ever available for sale at Meadview. Located within the boundaries of the Lake Mead National Recreation Area, Meadview Terrace features paved streets, water & electricity included in the price of the lots.

**FEBRUARY 1967**– Frank & Clotee George have moved a 12 x 55 foot mobile home to Meadview Terrace.

**OCTOBER 1967**– Paving of Pierce Ferry Rd begun. Mt Tipton Elementary School in Dolan Springs opens for local children who were formerly bussed to Chloride.

**APRIL 1968-** Rivcor president, Frank Glindmeier, has announced that the entire Rivcor organization will move its main offices to Meadview during the month of April. Hank & Fran Wilson spent some time surveying their lot in Meadview Terrace. Their problem was "Where can I build our house and save the Joshua tree?" Hilda & Dick Kokesh of San Diego, Ca., are proud owners of lot 238 in Meadview Terrace. They will be moving here soon. Rivcor (developers of Meadview) & Lake Mead Land & Water Co. (developers of Lake Mead City) enter into an agreement with the Mohave County Board of Supervisors to purchase oil for the paving of the balance of Pierce Ferry road.

JULY 1968 – Pierce Ferry Road paving completed

**OCTOBER 1969**– First striped Bass (Stripers) stocked in Lake Mead by the Arizona State Fish & Game Dept.

*JULY 1970*– Mail service to Meadview begun, mail is delivered to boxes near the Meadview Sales office on Pierce Ferry Road.

**SEPTEMBER 1970**– The Meadview Civic Association, Inc., a non-profit corporation, organized under the laws of the State of Arizona. Duane Johnson opens new business, a real estate office. This area is not new to Johnson, who first visited here in 1960 & moved here in 1967. Final development plans for the community of Meadview are announced. Landex Corporation is formed to take over the Meadview development from Rivcor.

OCTOBER 1967 – Unit 4 sales open.

**NOVEMBER** 1970– Dry storage yard is opened & the Meadview Marina Motel opened for business. James & Helen Turner are busy building a garage & workshop to go with their double wide mobile home in Meadview Terrace. Bob & Opal Fry of Oxnard, Ca., are part time residents in the Terrace. The Fry's are into speed boat racing, & have raced the Hot Yot in many events

**DECEMBER 1970**– Unit 6 sales opened. The Meadview Marina Laundromat, owned by Roger & Patty Tomczek, opened for business October 15th. Costing \$.35 for washing & \$.10 for drying. Meadview gets a first aid station. Jean Donathan, (Tex's wife), is an R.N. & has volunteered to help in an emergency. Landex has acquired first aid supplies, including oxygen equipment for her use. Meadview resident, Jim Dill, has been around, & around the world 2 1/2 times. The Dills, Jim & Hazel will soon celebrate their second anniversary as Meadview residents.

**JANUARY 1971**– Construction begins on the Civic Center, ground was officially broken in September after 90days of planning. The very best 9 acres of land in Meadview was donated to the MCA by Frank Glindmeier & Paul Mullane.

MAY 1971 – Civic Center swimming poll is completed.

*JULY 1971*– Construction of Civic Center completed. The grand opening ws held on July 4th.

**OCTOBER 1971**– Contract signed between Landex & Citizens Utility Co. to provide electrical & Telephone service to Meadview.

JUNE 1972 – Unit 8 sales opened

**SEPTEMBER 1972**– Meadview lights up as electrical service comes to town.

**DECEMBER 1972**– Telephone service connected to Meadview.

**FEBRUARY 1973**– Our children ride in style as the school bus service come to Meadview.

*MARCH* 1973– Construction begins on new wing of Civic Center, to be donated to MCA by Landex.

*JULY* 1973 – Medical clinic opens in Dolan Springs.

**NOVEMBER 1973-** Terrace Two, Valley One & the Highlands are opened for sale.

**MAY 1974**– Bob & Marianne Huffer open the Meadview Market.
