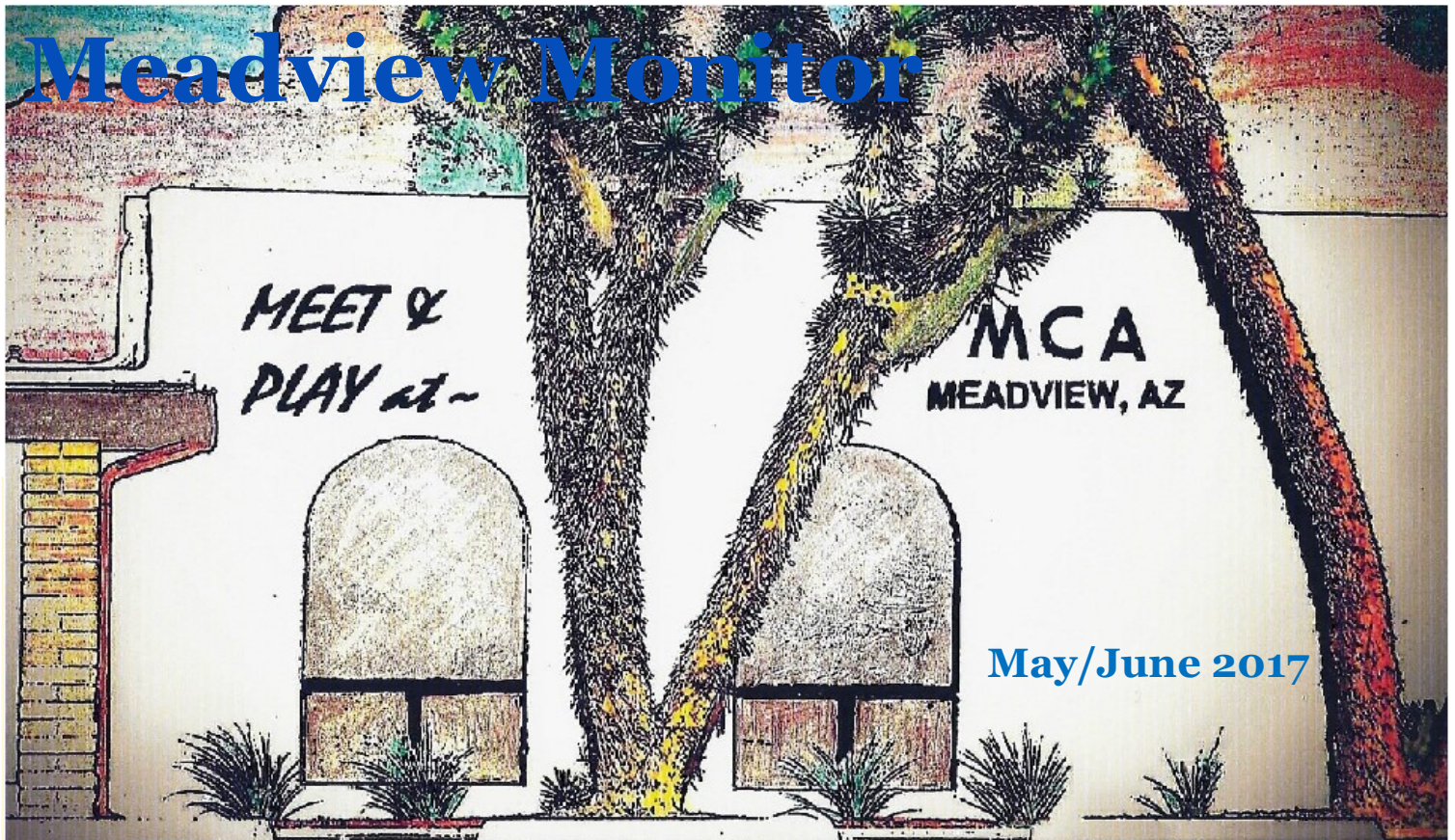

BLIGHTED PROPERTIES

The MCA has received many complaints over the years regarding “blighted properties” in our community.

We have addressed these concerns at several of our membership meetings. We would, again, like to provide that same information for our members who still have questions about what is actually being done to resolve this ongoing problem.

Neil Baker, the Chairman of our Architectural Committee, has spent dozens of hours identifying these properties, researching the ownership, and contacting these property owners in an attempt to resolve the problems. There are several issues that must be considered and addressed in his attempt to resolve each property’s individual condition.

THE ONGONG ISSUES:

1. Not all properties are MCA membership properties, so we have no authority to even enforce MCA rules and regulations.
2. No one may enter any property without express permission from the owner.
3. In many cases, the current owner has passed away and ownership has never been changed; thus, current ownership is unknown. It is impossible to determine, who “exactly” is responsible for the condition and care of the property.
4. Sometimes, the current owner has not seen the property in many years and is not even aware that someone else may have dumped trash and garbage onto their property.
5. Many of the properties have years of unpaid back taxes, thus, there is little or no value to the property.
6. The County would like to bring these properties up to a clean and presentable condition, but Funds and Manpower are limited. The County can only help us with about 3% of these issues.

WHAT THE MCA IS DOING TO CORRECT THE PROBLEMS:

First, it is necessary to identify the property and attempt to contact the current owner.

If possible, an effort is made to work with that owner to see if we can work together to clean up the property.

Identifying ownership is sometimes very difficult or even impossible. With no response or contact with the owners, Neil approaches the Mohave County authorities for assistance.

He is currently working with Mohave County in an attempt to have them assist him in an appropriate and legal manner to resolve each problem. Those departments are: Building Code Enforcement, Abatement Agency, Health & Safety, Assessor’s Office, County Treasurer and County Recorder. When all information is compiled, it will be presented to Supervisor Jean Bishop.

SUGGESTED SOLUTIONS:

1. A cooperation between the MCA, community organizations, and individual volunteers to work together to address these properties and “cure” the blighted conditions.
2. When there are years of unpaid back taxes and there is no other resolution, we have a suggestion to approach the County Supervisors with a process. The plan would be: **(a)** Foreclose on the property for the back taxes. **(b)** Have the County Treasurer forgive, or waive, the back taxes. **(c)** Put the property up “for sale.”

NOTE: The decision “to waive the back taxes” must come from County Supervisors.

3. We can, as Meadview residents and Meadview volunteers, work with the individual County departments to improve all our properties for a better, cleaner and well-kept community. This will add value to all Meadview properties and benefit all of our investments.
4. A non-profit organization could be created as a community improvement plan. Suggested name: “Meadview Beautification Team.”

Residents are urged to participate, as we need to show “unity.”

Special Notice to ALL MCA Members Legal Notice of Election

I. Candidate Eligibility:

A slate of candidates, all of whom are members in good standing of the Meadview Civic Association, shall be selected by a nominating committee. The consent of all candidates shall be obtained before placing their names on the ballot. At the annual meeting a member present may nominate a member for the Board of Governors. No write-in candidates shall be accepted unless nominated at the annual meeting. No member nominated at the annual meeting shall be considered unless the candidate consents to serve if elected. The presiding officer shall limit nominating speeches from the floor to one (1) minute each.

II. Who May Vote:

Only members in good standing will be eligible to vote. To be a member in good standing means that all association assessments on lots being voted, have been *paid in full by 2 p.m., the Friday prior to the Annual Meeting.*

III. Voting Eligibility:

A person eligible to vote in this election must be the owner or co-owner of Meadview property which is presently being assessed by the Association. One vote only may be cast for each lot so assessed. Where a lot or lots are owned by one or more persons, only one of the persons named as co-owner may vote for any one lot. Only one vote per lot is allowed. You may vote by absentee ballot if unable to attend the meeting. You must request your absentee ballot from the Secretary of the Board. Carefully follow the instructions sent with your ballot (s) and return to the Secretary. *Absentee Ballots must be received by the Secretary of the Association by the close of the last business day prior to the Annual Meeting.*

IV. Verification of Voting Eligibility:

Each prospective voter will be required to present proper identification prior to receiving the ballot (s) for voting. Association records will be checked to verify that such person is a member in good standing. Each prospective voter will then be given the specified number of ballots, one for each member lot, and will then cast his/her ballot (s) immediately after verification. Voting hours shall be from the conclusion of the annual meeting to 2:00 p.m. There shall be no electioneering within one hundred (100) yards of the polling place.

V. Ballots for Voting:

Subsequent to verification of eligibility to vote, members will be given one (1) ballot for each lot for which he/she is authorized to cast a vote. Members, after verification of eligibility to vote, and receiving the ballot (s) shall proceed to vote and deposit said ballot (s) in the ballot box within ten (10) minutes. A member voting for more than ten (10) ballots shall have multiples of ten (10) minutes for each ten (10) ballots being voted.

VI. Voting Procedures:

A. In accordance with the desires of the majority of the Association members as expressed at the May 28, 1988 meeting and at the prerogative of the present Board of Governors as authorized in Article III, Section I of the By-Laws of the Association, the number of persons to sit on the Board of Governors shall be seven (7).

B. Place an "X" in the box beside the name of each candidate you wish to vote for. On all propositions, place an "X" in the appropriate box. On all proposed By-Laws changes mark an "X" in the appropriate box.

C. Fold your ballot and deposit in the ballot box provided. *Note: Voting for more candidates than seats available will invalidate the ballot.*

VII. Ballot Counting:

A. After all the ballots have been cast, the Election Committee will open the ballot box and proceed to count and record the votes.

B. To verify proper performance in all aspects of the election, the election will be monitored by appointed Association members.

Installation of Officers:

A. Immediately after the determination of names of the winning candidates, the newly elected members will assume their positions on the Board.

B. In accordance with Article III of the Association By-Laws, the Board members will be elect executive officers from their own ranks. The executive officers of the Association shall be President, Vice-President, Secretary, Assistant Secretary, Treasurer, and Assistant Treasurer.

C. This Board of Governors shall manage and control the business affairs of the Association in accordance with the terms and conditions of the Articles of Incorporation and the By-Laws of the Association.

Voting by Absentee Ballot:

Members can request an absentee ballot, one for each lot on which an assessment is paid, which will list the slate of candidate dates, Propositions, and the proposed By-Law changes. The request form for absentee ballots should be filled in and mailed to:

Upon receipt of the request form, eligibility and number of votes entitled to be cast will be determined. The ballot (s) will be mailed to the requester with a return envelope addressed to the Secretary of the Board. After indicating your choice of candidates and By-Law changes, seal the ballot (s) in the envelope addressed to the Secretary. *Walk-in and mailed Absentee ballots will be accepted until, 2 p.m., the Friday prior to the Annual Meeting. Absentee Ballots **received after 2p.m. the Friday prior to the Annual Meeting by walk-in or mail pick-up, will be invalid.***

Upon receipt the sealed envelope with the absentee ballot showing the date received from the voter shall be logged in and placed in a locked ballot box. On election Day, the Election Committee will remove the ballot from the envelope for counting purposes.

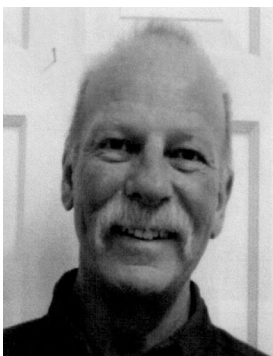
Biography

BLAST FROM THE PAST, SEPTEMBER 1967

Meadview Adventurer's Scored Again Garnet Mine Junket Proved Most Enjoyable

The back country trek to the Iron Mountain Garnet Mine, taken on Aug. 19, 1967, was the 11th successful outdoor event sponsored by the Meadview Adventurer's Club since the Club was organized. These outdoor events have been very well attended and judging by the remarks, have been fully enjoyed. The Meadview Adventurer's Club, (M.A.C.), is a non profit organization which has no dues, no meetings and no officers, except a Co-ordinator. The Club consists of individuals who have participated in one or more of Meadview's outdoor activities. These are family type events and all ages can participate and enjoy them. By participating in any of the events one automatically becomes a member and is issued an attractive wallet size card, with the participants name on it.

In line with these activities, Hal Brown, Co-ordinator of M.A. C., gives this report on the recent trip taken to the Garnet Mine. On Saturday, Aug. 19th, eighteen adventure minded folks left the Meadview complex at 10:00 a.m., Arizona time, and headed for the Garnet Mine, nestled on the southwestern slope of Iron Mountain.

None but myself knew what lay ahead and it made for much excitement and anticipation. The first part of the journey passed through the beautiful high desert Joshua forest and traveling on good graded road, in and among these huge giants, gives one a very restful feeling. The road winds through this country lending a new, panoramic view each time it rises up over a knoll or enters a draw.

Things begin to toughen up a bit as several washes are crossed or traversed for a short distance, and Grapevine is one such place. This is the major wash at the west end of the mountain range known as the Grand Wash Cliffs. Hundreds of square miles of surface water is drained from this range of mountains into Grapevine Wash and then flows northward to Lake Mead.

Evidence of the summer thunder showers was seen as the caravan traveled through the washes, but this posed no problem as the water had

packed the sand and made it easier to pass over and through. Dry, Sandy areas are the most hazardous for the off road desert traveler, therefore the M.A.C. advises to use only sand buggies, 4 wheel drives or for the more hardy, trail bikes. Even so, any wash should be traveled with caution and the best policy is to travel with a at least two or more vehicles.

After traveling an hour or so, the Garnet Mine road turns into a shallow valley and at this point the vegetation has made a distinct change. One sees live oak trees, dwarf conifer pines, sage and various other plants, too numerous to mention. It seems the desert is reluctant to give up its growth to the higher elevation, for in spite of the fast up climb the countryside was still covered with lush growth

It was at this point that this semblance of a road started its fast uphill climb and the vehicles jogged along over rocky outcroppings, gullies caused by the rains, small boulders and bits of debris strewn here and there. In the distance of approximately 7 miles the road ascends about 2000 feet, so all the vehicles, which were fully loaded with passengers, were put to a good test.

The caravan included 3 vehicles, a Jeep, a Toyota and a Volkswagen sand buggy, mine. The buggy was on its initial excursion and held up beyond expectations. Also present were three trail bikes, and those riders agreed that this country was made for fun and excitement on a trail bike.

On the way up we stopped at the abandoned miners shack, for a rest. This small building was someone's dream and is situated in a beautiful valley. There is a spring in a draw at the rear of the house and on the bank of this draw are two apricot trees, still very good specimens. Close to the house and along side of the trail is a very rustic paling corral. All this adds up to a very restful, peaceful setting and my hat's off to the early pioneer that had foresight enough to see this when he chose his building site.

On up to the mine area we

proceeded and before anyone did any scouting we had a restful and much enjoyed lunch under some of the many pines that dot the mountainside. In the party were Caroline Kelley and Kathy Taylour, of Long Beach, Earl Foshee of Azusa, Calif., Irven "Whitey" Penland and Johnny Smith of Bagdad, Arizona, Bob Genung, John Damanoff, Deaun and Jeri Lou Johnson, all of Phoenix, Pat Denny of Newhall, Calif., Lou and Maxine Davis from Santa Barbara, and from Meadview Frank and Clotee George, Blackie and Marguerite Blackstock and of course yours truly and wife Jackie.

The Garnet Mine tailings dump gave up several very good specimens and I'm sure we'll see a ring setting or bolo tie clasp made from one or more of the garnets. Whitey was the most determined hunter of all and came up with the most, and some of the nicest samples. Lou Davis did a different kind of hunting and that was for scenes to capture with his unusual camera arrangement. Lou has a large telescope to which he can attach a 35mm camera and with this setup can photograph areas at a great distance and the results are beautiful pictures.

It was difficult to tear ourselves away but we did finally head for home. Always on an outing such as this, there are a few minor incidents that seem to crop up and this trip was no exception. Besides having to shift passengers around for better weight distribution, there were a few bike spills, caused by loose sand and gravel, carburetor adjustments, a flat tire and one bike ran out of gas. These type of incidents, though a nuisance at the time, add to the excitement and make for good conversation at the end of the day. All arrived back at Meadview safe and happy and looking for the world like they had been through a dust storm. The cure to that was to head for South Cove and a much needed swim. An impromptu steak barbeque was held that night and it ended a very, very nice day Jackie is convinced that the ONLY way to take this kind of a trip is in a sand buggy and she's ready to go again.

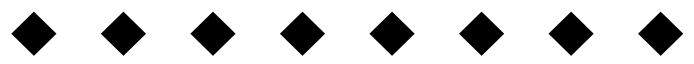

EXPLORERS /OVER the HILL HIKERS

Seven hikers met at South Cove Picnic area to hike into the canyons beyond the Ramada. The day was cool, but sunny, and the flowers were fantastic. The hike was led by Joan Stoops and everyone returned to the Ramada ready to picnic on hotdogs, beans and side dishes. Five others joined around the picnic table and we enjoyed the sunshine and some great rice krispies cake. Later, on March 6th, we hiked the railroad tunnels going to Hoover Dam. That day was windy and the hike was long, but the history of the building of Hoover Dam was really interesting. The tracks were built to haul in

the rock and concrete that was used to build the dam in the early to mid '30's. Twelve of us traveled Highway 93 and then the 13 miles into Eldorado Canyon to hike into the canyons just above the Colorado River. When we finished lunch we drove the last half mile to the river, where we visited with tourists from Oregon, Georgia, California and many other states who were doing an ATV tour out of Vegas coming.

We have set up (once again) a drive to Wickieup then hopefully we'll get to tour 17 miles of scenic desert flora including Palo Verde, Saguaro, Cholla and Pancake Prickly Pear cactus, Juniper and Cottonwoods along the Big Sandy River. This will be on March 21st. On March 24th we hope to hike the Monolith Gardens just to the west of Kingman. The 3rd of May we will do an all day trip to the Overlook (Rampart) on the Grand Wash Cliffs above Meadview. We will visit the Lake Mead City Overlook, then drive north as far as we can go, then come back to the Meadview Overlook. Some will be staying overnight after watching the sunset from that vantage point, so if you want to join up, bring your tent, or your pickup camper and join the group.
