

FRIENDS OF THE AZ JOSHUA TREE FOREST

Friends of Arizona Joshua Tree Forest is a non-profit 501c3, whose mission is to preserve, and protect the Grapevine Mesa Joshua Tree Forest ACEC(Area of Environmental Concern)/NNL (National Natural Landmark). We are an all-volunteer Friends group supporting BLM (Bureau of Land Management) in the agency's efforts to maintain and preserve our the Joshua Tree Forest in the Meadview area As part of our duties we regularly monitor the Joshua Tree Forest and report back to BLM if we see issues that may harm the integrity and preservation of the forest. A few weeks ago one of our volunteer monitors discovered an ATV trail that took off over virgin desert soil to connect with an abandoned road. We immediately contacted BLM and within hours we were out in the forest with staff from BLM to reclaim the unauthorized trail that connected to the old abandoned road. We had no time to contact other volunteers or our community. We pulled together a quick team of volunteers trained in reclamation projects, these volunteers have spent the last 10 years working with BLM on similar projects. As part of the reclamation project in the forest we carefully transferred some downed and dead Joshua Trees, carrying them to the disturbed area, by doing this the dead Joshua Trees decompose adding needed nutrients to the disturbed are, thus reclaiming the desert, we do not pull up any living plants and what raking is done is just to loosen the dirt on the disturbed area so new growth can then start. A good example of a successful reclamation project can be seen at the end of Smith Road in Lake Mead City. You can no longer see the road that had basically become an all vehicle road a few years ago. As a support group for BLM we will never do a project in the forest without the permission of BLM. Projects are always done with one or more of BLM staff working with us.

Regarding the abandoned road, that we also reclaimed, this is an old road that goes nowhere it ends at the fence, which was installed at the time Diamond Bar Road was paved. The fence is owned in part by the Hualapai Nation and BLM. The fence is a requirement of ADOT (Arizona Department of Transportation) to prevent cattle from crossing the road. The old road is not a good fire break and never would have been. Our efforts to maintain a viable forest and good places for our community to recreate without destroying our beautiful forest is one of our main objectives, your help in this endeavor is appreciated. We are always looking for volunteers to help with our ongoing projects, like the study plots within the forest, education of the importance of nature in our everyday lives, research on the history of the forest, or what our changing climate is doing to the Grapevine Mesa Joshua Tree Forest. We look forward to working with our community on many other important upcoming projects.



A PRE VIEW INTERVIEW WITH THE DEVELOPER BY A

ER BY HERB VOIGT

THE MEADVIEW CIVIC CENTER IS THE FOCAL POINT OF MANY MEADVIEW ACTIVITES. REGULARLY SCHED-ULED EVENTS INCLUDE POLL GAMES, CARD NIGHT, BINGO, HOBBY GROUP MEETINGS, AND EVEN AN OCCA-

The following interview was conducted between myself & Frank Glindmeier just prior to the publication of this issue.

H.V. You've been away from the land development business for some time haven't you, Frank?

F.G. Yes Herb. My wife, Lee, and I retired in 1976, and we've done a lot of traveling since that time, but a place like Meadview will always bring you back.

H.V. Unlike your previous developments, this one is acreage only, isn't it?

F.G. Yes. We decided that there was a definite need for acreage parcels at Meadview, since in its 25 year history there has never been any available. We therefore have taken a section of land that was set aside for future developments and are now dividing it into 15, forty acre parcels.

H.V. Where is your acreage located?

F.G. Herb, you're familiar with the downtown City Center area of Meadview around the Meadview Civic enter, aren't you?

H.V. Yes.

F.G. Well, the new acreage development of Meadview Country Estates is located immediately South of the subdivision of Meadview city Center, and also East of Meadview 8. Sandy Point Drive, a paved major street thru Meadview, runs along the West line of Meadview Country Estates. It's just a couple of minutes from anyplace in Meadview Country Estates to the facilities available what in what we refer to as "downtown" Meadview.

H.V. That sounds like a pretty handy location. How about the utilities situation?

F.G. The main power and telephone lines coming into Meadview run along Sandy Point Drive which is the West line of this section. Several parcels front on Sandy Point Dr., so electric and telephone service is immediately available to them at no extension cost. Other parcels are a little more distant from the utility lines and will require varying extension costs for their services, unless the lines have already been extended into the development. As for the water supply, each purchases has four choices. First of all, a major water main runs along Sandy Point Dr., and is part of the overall Meadview Water System serviced by Joshua Valley Utility Co. At the present, the subdivision of Meadview Country Estates lies outside of the franchised are o Joshua Valley Utilities Co., but they may be willing to serve this area in the near future. Secondly, a purchaser may drill their own well on any of the parcels. As a third option, some purchasers may choose to utilize a water trailer or truck and haul their own from the central water supply available in Meadview Unit 2. This is approximately one to two miles from the different parcels in Meadview Country Estates. Lastly, and the simplest way to go, is to pick up the telephone and call for water delivery service. This is what we have done for our home which we recently built in Unit 3. Incidentally, the price of what at the central supply is \$0.25 per 125 gallons or \$1.00 per 500 gallons. Since the average usage around her per month, that's only \$4.00 per month for water.

H.V. Speaking of water systems, isn't Meadview unique in having one of the better water systems in Arizona?(Continued Next Issue)


Meet our new Member Service Team: Virginia Classen and Deb Henneke
